## Submission Requirements

1. **CRITERIA.** All projects must be additions, renovations, or restoration of an existing structure. Each project may only be entered in ONE category.

**Category 1 Kitchen Remodel**

A. Up to 149 sq. ft. finished B. 150 – 399 sq. ft. finished C. Over 400 sq. ft. finished

**Category 2 Bath Remodel**

A. Up to 149 sq. ft. finished B. 150 – 399 sq. ft. finished C. Over 400 sq. ft. finished

**Category 3 Addition**

A. Up to 299 heated sq. ft. added B. 300 – 699 heated sq. ft. added C. 700+ sq. ft. added

**Category 4 Full Renovation**

A. Up to 1,799 sq. ft. finished B. 1,800 – 3,999 sq. ft. finished C. Over 4,000 sq. ft. finished

**Category 5 Exterior Renovation**

**Category 6 Outdoor Living**

Judges may give awards for special conditions within each of the above categories including Commercial Renovations and Universal Design. Please check the corresponding box on the Entry Form so judges know what to look for on your project.

- **Universal Design projects** must include information on specific items that make this project stand out in that regard. Homes that are Certified Universal Living are preferred to other such certifications or no certification at all.

**Complete entries must include the following:**

- **NOTE: ALL ENTRIES WILL BE SUBMITTED ELECTRONICALLY. FORMS CAN BE IN .PDF FORMAT OR SCANNED DOCUMENTS. SUBMITTED IMAGES MUST HAVE THE CATEGORY NAME AND COMPANY NAME IN THE FILE NAME. SEND ENTRIES TO [BIN@COLUMBIABUILDERS.COM](mailto:BIN@COLUMBIABUILDERS.COM) BY THE DEADLINE.**
  - Completed Entry Form
  - Description of Project Including Products/Vendors used
  - Owner Participation Form (Filled out by Homeowner/Property Owner)
  - Before and After Plan, Elevation or Section
  - BEFORE Photos - A minimum of one (1) photo of each remodeled area to be considered, included with entry, with category number and company name in the file name (i.e. Cat1\_CompanyName\_Before1.jpg). Before photo of an addition can be the exterior or interior where the addition is to be added.
  - AFTER Photos (All projects). ALL photos must be in color, category number and company name in the file name (i.e. Cat1\_CompanyName\_After1.jpg). Minimum of two [2], maximum of ten [10] included with entry materials.
  - Entry Fees: \$150 per entry. If entering three or more entries, deduct \$25 per entry. Make check payable to BIA of Central SC. Credit Card payment also available (+3% convenience fee).
2. **ELIGIBILITY.** Entries must be submitted by a member of the BIA of Central SC Remodelers Council in order to be eligible. The project must have been **completed** between September 14, 2021 and August 14, 2022, and located in the Greater Columbia area (Kershaw, Lexington, Richland, Sumter and Newberry Counties).
  3. **ENTRIES.** A separate entry form must be submitted with each project entered with related support materials. The entry form must be completed and all entry requirements must be satisfied to be eligible. All support material should be appropriately labeled with category number and company name. All support materials must be submitted electronically via e-mail or file sharing service such as Dropbox.

4. **PHOTOS: ALL photos must be in color, with category number and company name in the file name. Entries without photos will be disqualified.** Photos can be vertical or horizontal. All submitted materials will be retained by BIA and be used in the on-line presentation of the entry, in print publications and other media.

By submitting materials in this program, you hereby grant the BIA of Central SC and it's agents or partners the right to use these materials in any and all promotional means.

5. **ENTRY FEE.** BIA of Central SC members in good standing may enter this awards program. Enter one (1) or two (2) project(s) for \$150 each. Enter (3) or more projects for \$125 each. Entry fees are non-refundable unless the entry is not judged. Please complete an entry form for each submission and return to the BIA office no later than the specified DEADLINE.
6. **DEADLINE.** All entries must be sent to [Bin@columbiabuilders.com](mailto:Bin@columbiabuilders.com) or delivered to 625 Taylor Street, Columbia, SC 29201 **no later than 5:00 p.m. on Monday, August 15, 2022. ABSOLUTELY NO EXCEPTIONS.**
7. **AVAILABLE FOR JUDGES CONSIDERATION.** Assume that your project will be judged solely on the materials submitted. Judges may or may not visit projects in person. However, judges and BIA Staff may contact the remodeling company and/or homeowner with questions or to request further information on the entry.
8. **JUDGING.** Distinguished experts selected for their expertise in the fields of design, building and remodeling, from out of the area, will judge the entries. Each entry will be judged on its own merits — only on the entry material submitted or requested during judging, and only as it relates to the judging criteria — by our panel of highly qualified, impartial judges. The panel of judges will grade *each* of the items listed under the *judging criteria* on the following point scale:

Poor .....	1 point
Good .....	3 points
Very Good.....	5 points
Excellent .....	7 points
Superior .....	10 points

Judges will consider and grade each project on Degree of Difficulty, Problem Solving, Aesthetics, Craftsmanship, Innovation, Functionality, and Entry Materials (complete and within the set rules). Judges may include other factors such as Budget, Special Circumstances or other applicable factors when making their final decisions. Assume that judges will only have the submitted materials by which to judge each entry. They may or may not visit the project in person, and they may or may not contact you or the homeowner with further questions.

The points awarded for each item under the *judging criteria* will be totaled to give a total number of points for that entry. If only one entry is received in a given category, the judges will have the option of deciding whether an award is presented in that category or not. Judges, in consultation with the Awards Committee and/or BIA Staff, will have the right to change the category for an entry if it is felt the entry does not qualify in the category for which it was submitted. The Judges may, at their discretion, create new categories as the need arises. The Judges may, at their discretion, give multiple awards in the same category. **The decisions of the judging panel are final.**
